Minority Business Enterprise (MBE) Eligibility Criteria

Minority shall be defined as stipulated by La. R.S. 38:2233.2E(1) (2), which are as follows:

(1) *Minority* means a person who is a citizen or lawful permanent resident of the United States and who is:

- a. American Indian or Alaskan Native: Having origins in any of the original peoples of North America.
- b. Asian American: Having origins in any of the original peoples of the Far East, Southeast Asia, the Indian subcontinent, or the Pacific islands.
- c. Black: Having origins in any of the black racial groups of Africa.
- d. Female.
- e. Hispanic: Of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish or Portuguese culture or origin regardless of race.

(2) *Minority business enterprise* or *Minority-owned business* means a small business organized for profit performing a commercially useful function which is owned and controlled by one or more minority individuals or minority business enterprises.

(3) *Owned and controlled* means a business in which one or more minorities or minority business enterprises own at least 51 per cent or in the case of a corporation at least 51 per cent of the voting stock and control at least 51 per cent of the management and daily business operations of the business. Disadvantaged Business Enterprise (DBE) Eligibility Criteria

The City of Lake Charles utilizes the Unified Certification Program (UCP) through the Louisiana Department of Transportation and Development (LA DOTD) to identify Disadvantaged Business Enterprises (DBE). This program identifies all firms eligible to participate as a DBE. It is important that you register with the UCP in order to be listed as a DBE with the City of Lake Charles. <u>A copy of the UCP certification must be submitted to</u> the City of Lake Charles Purchasing Division for inclusion on the DBE list.

Small Business Enterprise (SBE) Eligibility Criteria

Small Business shall be defined as stipulated by La. R.S. 38:2233.2E(1) (2), which are as follows:

- (1) "Small Business" means a business entity organized for profit, including an individual, partnership, corporation, joint venture, association or cooperative which is domiciled in and has its principal place of business in Louisiana and which is not:
 - a. Dominant in its field of operation or
 - b. An affiliate or subsidiary of a business in its field of operation.
- (2) "Dominant in its field of operation" means exercising a controlling or major influence in a business activity in which a number of businesses are engaged. In determining if a business is dominant, the following criteria, among others, shall be considered: Number of employees; volume of business; financial resources; competitive status or position; ownership or control of materials, processes, patents, license agreements and facilities; sales territory; and nature of business activity. The following businesses shall be deemed dominant in their field of operation:
 - a. Manufacturing businesses which employ more than 100 persons and have in the preceding three fiscal years exceeded a total of \$15,000,000.00 in gross receipts.
 - b. Nonmanufacturing businesses which employ more than 25 persons and have in the preceding three fiscal years exceeded a total of \$3,000,000.00 in gross receipts.
- (3) "Affiliate or subsidiary of a business dominant in its field of operation" means a business which is at least 20 percent owned by a business dominant in that field of operation, or by partners, officers, directors, majority shareholders, or their equivalent of a business dominant in that field of operation.
