THE FOLLOWING RESOLUTION MAY BE ADOPTED BY CONSENT

1. 434-25

A resolution selecting the former Capital One Tower site for the Indoor Sports Facility, such selection conditioned upon applicable State and Federal funding partners' approval of the site.

Those speaking in favor of the Capital One location were as follows: Jacob Rafferty, 1718 W. Common Street, Lake Charles, LA was in favor although he did not wish to speak. Jim Rock, 3939 Buccaneer Lane, Lake Charles, LA on behalf of Community Foundation and Lake Area Industry Alliance spoke in favor. Jay Ecker, 700 Royal Street, Lake Charles, LA was in favor although he did not wish to speak. Eric Zartler, 1205 N. Lakeshore Drive, Lake Charles, LA was in favor although he did not wish to speak unless requested to provide information. Dave Evans, 719 and 949 Ryan Street, Lake Charles, LA, owner of Luna's and Augustine's was in favor. Those speaking in favor of the North Lake Charles location were as follows: Miles Brown, 1020 4th Avenue, Lake Charles, LA would like to see the city exhaust all avenues in North Lake Charles first before changing the location. Shawntel Willis, 2720 Alice Street, Lake Charles, LA stated she would like to see the site stay in North Lake Charles. Jacob Rafferty, 1718 W. Common Street, Lake Charles, LA requested to speak and stated he was in favor of the Capital One site but also in favor of North Lake Charles getting something in the

community. Willie King, 1611 Gerstner Memorial, Lake Charles, LA stated he was part of Project Build A Future and was in favor of the North Lake Charles location. Wanda King, 2118 Knapp Street, stated she was in favor of the North Lake Charles location. Gene Thibodeaux, 3910 Marie Court, on behalf of RENEW Lake Charles, spoke regarding the opportunity zone at the Capital One site and that the sports complex in Bryan, Texas had expenditures that exceeded the revenues. He stated he was opposed to the site because they were still looking at the site for a 200 room hotel and would like to take advantage of the opportunity zone. Mr. Bilbo and Mr. Young expressed concerns about losing the project altogether if it were not acted on. Mr. Marks stated that he had a 10 acre site in his district that he had submitted to the council and administration for consideration. Mayor Simien addressed the council and stated that this project should also be utilized as a resiliency hub during a disaster. He further stated that the appraised value of the Fitzenreiter property was \$830,000.00. He further explained the three objectives for obtaining the funds, 1) had to benefit low to moderate income persons, 2) prevent or eliminate slums or blight and 3) had to meet other community development needs having a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community and other financial resources are not available to meet such needs. After discussion from each of the council members, Mr. Young called for the question which was seconded by Mr. Bilbo. The council voted as follows:
