John leyoub welcomed Police Juror Brian Abshire, 2038 St. Joseph Ave. representing the residents of Heard Road. Mr. leyoub read a letter from Bryan Beam, Parish Administrator, who requested consideration of a drainage impact analysis be performed. The letter was made a part of the record.

Mr. leyoub wants to make sure the drainage is okay. Mr. Cardone stated the developer is responsible for the drainage impact study.

Mr. leyoub recommended placing a condition to require a drainage impact study be done for any size development on the property. He stated as long as a study is done, annexed or not, it should satisfy the constituents.

Mr. Abshire described the project as a commercial strip center with town home development behind it.

Mr. James Dong, 3509 Heard Road, spoke, stating he lives adjacent to the property and he fully supports the drainage impact study and wants to make sure the study is done. Any person who believes him/herself or any specific class of persons, to be subjected to discrimination prohibited by Title VI and/or Americans with Disabilities Act may by him/herself or by representative file a written complaint with the City of Lake Charles.
