#### AMENDMENT TO ADD CDBG-CV CARES ACT FUNDING TO THE FY2019 ANNUAL ACTION PLAN

#### **Executive Summary**

#### 1. Introduction

The Consolidated Plan serves as a planning document meeting the federal government statutory requirements in 24 CFR 91.200-91.230, with revisions for preparing a Consolidated Plan and guiding the use of CDBG, HOME, HOPWA, and ESG funding based on applications to the U.S. Department of Housing and Urban Development (HUD). The major sections of the Consolidated Plan include a Housing Market Analysis, Housing and Homeless Needs Assessment, 5-year Strategic Plan, a 1-year Action Plan, Consultation and Citizen Participation, with accompanying documentation relating to public comment. The Strategic Plan addresses specific needs that were identified in the data analysis, with specific goals and program targets for each category designated for funding. The Action Plan is a subset of the Strategic Plan.

The City's proposed allocation for FY 2019 consists of a total of \$ 981,953 with an additional \$ 165,157 in Program Income and \$1,005,428 in CDBG-CV funds.

This Action Plan contains a range of goals, objectives, and outcomes formulated to address needs identified for homelessness, other special needs, affordable housing, non-housing community development, barriers to affordable housing, lead-based paint hazards, institutional structure, and coordination. These objectives include:

- Continue to collaborate with homeless providers to supply a continuum of services
- Support services aimed at the prevention and elimination of homelessness and Rapid rehousing

- Improve the condition of housing for low-income homeowners
- Increase the viability of potential homeownership opportunities
- Improve the condition of housing for low-income renters and homeowners through relocation services
- Support improvement of infrastructure and public facilities in CDBG targeted areas of Lake Charles
- Removal of Slum and Blight Conditions
- Address community needs through community-based public service programs

These goals are supported by a collection of associated objectives and performance goals. These objectives seek to work toward meeting the goals stated, addressing the need for more affordable housing, housing rehabilitation, public facilities, infrastructure improvements, and social services.

#### 3. Evaluation of past performance

This is an evaluation of past performance that helped lead the grantee to choose its goals or projects.

The City of Lake Charles has a history of successful programs funded through the Community Development Block Grant and HOME Investment Partnership Program. Of particular importance to the health of the city have been programs that address the condition of the housing stock. The City has successfully funded Homeowner Rehabilitation activities targeting lower income and elderly households unable to properly maintain their homes. The City also operates a successful program that provides Homebuyer Assistance to new homebuyers. The City is working to remove the dilapidated housing stock in the CDBG eligible areas through demolition and major rehabilitation programs. Details of past performance can be found in the City's Consolidated Annual Performance and Evaluation Report (CAPER).

During the 2017-2018 fiscal year, the New Orleans Field Office monitored the City of Lake Charles' Community Development Division, there were Findings and Concerns that the City must address.

FINDING NO: RM17002: PJ Committed to CHDO Funds to a Project that is not Eligible CHDO Activity.

FINDING NO: RM17001: Less Than one-third of Board Members Represent low-income community.

FINDING NO: RM17003: PJ Failed to inspect HOME rental units during affordability period.

Concern No. 1: The PJ needs to improve its management of CHDOs

In 2018, the City of Lake Charles forwarded all required documents to the field office. HUD has stated that the city of Lake Charles has met all required actions, and is in compliance with all of our findings and concerns.

The City has ongoing relationships with housing providers (CHDOs) working on housing development activities. The CHDO system provides a forum for assisting these agencies to grow and meet their targeted clientele. The City works closely with the Housing Authority of Lake Charles which organizes resources from the federal government to address the housing needs of the City's lowest income households. The City participates in a variety of other coalitions that seek to address other issues that relate to housing and service needs.

City staff works actively with the Southwest Louisiana Balance of State, the local umbrella for the development of the Continuum of Care. Staff participates in regularly scheduled meetings and point-intime surveys. In the past, the City has often brought CDBG resources to the table to supplement Continuum of Care initiatives and distributes CDBG funding to the various agencies that make up the membership of the continuum.

Staff from the City of Lake Charles participates in the development of the SWLA Balance of State, working with area service providers to include City resources, to the extent possible, in the provision of services to homeless individuals and families in Lake Charles. The Calcasieu Parish Police Jury will assume the responsibility of ESG. This will all individuals from the surrounding areas to be served as well.

Home match will be provided from the City's General funds with the exception of Administrative fees (100% federal). (12.5% of HOME project expenditures). The City has also accumulated Program Income from the HOME program in the amount of \$ 165,157 and \$1,005,428 in CDBG-CV funds to respond to the effects of the Coronavirus pandemic.

The City will continue to emphasize expropriating abandoned and adjudicated property to make property available for profit and non-profit developers to build affordable housing development.

#### Discussion

The City was allocated \$981,953 from the CDBG and HOME programs for the 2019 Program Year. These funds will be used to operate a range of private and public services as described later in the Annual Action Plan. The City has obtained Program income from the Home funds that will be used for the Major Home Rehabilitation program. The City has also accumulated Program Income from the HOME program in the amount of \$ 165,157. Lastly, the City is receiving \$1,005,428 in CDBG-CV funds to respond to the effects of the Coronavirus pandemic.

# Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The SWLA Balance of State, the coalition of local homeless service agencies, conducts annual surveys of homeless individuals, including unsheltered persons. These surveys serve to help focus agency activities for the coming year, as well as provide documentation in response to HUD's program requirements. Also, Lake Charles City Police has created a record of where the homeless population lives within the city limits of Lake Charles.

### Addressing the emergency shelter and transitional housing needs of homeless persons

Homeless providers are focusing efforts on increasing the bed count for both emergency shelter and transitional housing programs. Funding for these efforts has been limited.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The Emergency Solutions Program includes activities targeting improvements in the areas of Rapid Re-Housing and Homeless Prevention. The Parish has taken over this program. The City of Lake Charles will be working with them on all endeavors.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services,

#### employment, education, or youth needs.

Homeless prevention is a major focus of the participants in the Southwest Louisiana Balance of State. Agencies include homeless prevention as a support program in conjunction with the provision of shelter and other support services. The City has facilitated the ESG program for over twenty years, but now the Parish will be conducting this program because they are able to reach those outside of the city limits, which we were limited to.

#### Discussion

The participants in the Southwest Louisiana Balance of State work closely together to meet the needs of homeless individuals and families through the continuum of care by partnering with different agencies. The City is a member of the board and participates in the planning process.

The City provides homebuyer assistance to families who are purchasing a home for the first time. These families are low/moderate income. Also, the City provides Major Home Rehabilitation to those who are low to moderate income and qualify for assistance. We, the City, partner with our local CHDO to provide construction of new homes that are sold to persons who are low/moderate income.

#### Actions planned to reduce lead-based paint hazards

- 1. Continue to meet HUD lead-based paint abatement standards in housing rehabilitation programs.
- 2. Identify additional funding to perform abatement on pre-1978 housing in the target census.
- 3. Seek funding as it becomes available to provide testing and abatement of lead-based paint hazards in single-family housing where young children are present.
- 4. Expand the stock of lead safe housing units through housing initiatives.
- Seek funding as it becomes available to provide for testing, abatement, training and educational awareness.

The City will continue its efforts, in conjunction with the SWLA Balance of State Continuum of Care and the Housing Authority of Lake Charles, to reduce the number of poverty-level families through the development of services such as educational opportunities, job growth and life skills training. #### **Citizen Participation Comments**

The Public Notice states that the City of Lake Charles received \$394,989 in CDBG CARES Funding. \$350,000 will be made available to small business that have been affected by COVID-19 and only \$44,989 will be used to assist tenants affected by COVID-19 with rental assistance. Through the U.S. Small Business Administration, businesses had access to the Paycheck Protection Program (PPP), Economic Injury Disaster Loans, SBA Express Disaster Loans and SBA Debt Relief.

The Louisiana Department of Treasury has also established The Main Street Recovery Grant Program to help small businesses recover from COVID-19 economic impacts. Business can apply for up to \$15,000 for this program.

Business may have also had access to Business Interruption Insurance or Contingent Business Interruption Insurance.

My point is that small businesses have been given multiple opportunities to receive assistance. The City of Lake Charles establishing a "Small Business Stabilization Fund" is a duplication of the many services that are already offered.

I have reviewed the "Small Business Stabilization Fund" plan that is posted on the City of Lake Charles' website. The plan states that ..."In order to comply with CDBG requirements, business must commit to retaining at least one employee form a low-moderate income household, defined as 80% or below Area Median Income (AMI)"... This performance measure is not giving our businesses high goals to shoot for. One employee, that is an extremely low number. The only number of employees lower than that for a business to retain is zero. Is \$5000 really going to save a business?

Individuals in our area are being laid off, furloughed, and terminated at an all time high. The Golden Nugget Casino announced that they were laying off 400 individuals alone . As I understand it, the City of Lake Charles has laid off some individuals as well. All that the City of Lake Charles feels appropriate to dedicate to help tax paying citizen's is \$44,989?

How far will this \$44,989 go? Not far at all. Let us think about this. Individuals who have been furloughed...If they are called back to work, they will have to repay their employer for the cost of their insurance benefits that the employer incurred while they were furloughed. Therefore, they will still not have a full paycheck. In some cases, the paycheck may be zero. The added unemployment benefits from the federal government have ended. The maximum benefit for Unemployment in Louisiana is \$247/week and this amount is only awarded to previous high wage earners. There are individuals seeking assistance in our community that has never found themselves in this position before.

These funds should be used to assist the individuals in our community prevent eviction, pay utilities, address food insecurities, etc. People should come first.

Funds must be allocated in areas where it will be of most benefit. The most benefit will be to individuals and not providing up to 70 businesses with only \$5000 each with poor performance measures. The City of Lake Charles is not being a good steward of federal funds regarding the amendment to the 2019 Annual Action Plan. When reviewing the notice I see that majority of the funds \$ 350,00 are going towards businesses, and the REMAINING 44, 989 is going towards rental assistance, which seems to me that the priority is not in the people who are suppose to benefit from CDBG funds. As a citizen in Lake Charles I am seeing many families getting evicted due to the fact the Lake Charles has the highest number of cases due to the outbreak. If families are homeless, they are not going to shop in at any business. There are several grants available for businesses, so as a tax payer I feel that they should be applying to those funds. \$5000 will not keep a business up and running. But \$5000 can keep families from being evicted for several of months. This was not thought out very well.

What happened to the meetings that asked the citizen on how we want the money to be spent. The focus needs to be on the people, I would think that this is not the priority of the City of Lake Charles.

These comments are in response to the City of Lake Charles Community Development Division amending the 2019 Action Plan to include funds from the CARES Act.

The proposed creation of a Small Business Stabilization Fund with an allocation of \$350,000 does not follow the intended use of the Community Development Block Grant program to develop "urban communities by providing decent housing and a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons." The one performance measure sets the lowest possible outcome requirement and demonstrates a lack of commitment to make the greatest impact possible with these funds.

In addition, multiple programs have been offered to small business to support their operations during this COVID pandemic. In the 70601 zip code alone, more than 100 businesses received funding from the Payroll Protection Program. At the same time the unemployment rate has risen from 5.3% in January of 2020 to 10% in June.

Food security, evictions, transportation issues and job availability for our most vulnerable population are not served by the Action Plan revision. I am not in favor of the City of Lake Charles' plan for amending the 2019 Action Plan.

On July 1, 2020, the City Council voted to amend the 2019 Action Plan to use the CARES funds for small businesses and rental assistance. Did the process with this funding change? In the past, we the citizens, have always been given an opportunity to submit comments before the City Council voted. I just don't understand why the City Council would vote on something without public input. Also, we usually have 15 days to comment. We only had 5 days this time. I looked on the City of Lake Charles website to see if any of these changes were documented. I could not find it anywhere. I could only find the information that confirms what I have previously stated. I would like to see more funding go towards rental assistance.

After hearing that the City has put most of this money towards business and not putt the money towards hard working, underprivileged people, I am very disappointed.

I strongly feel that more money needs to go to citizens who are low to moderate income that are facing serious financial issues during the pandemic. Business have other opportunities through the state and federal government for bailouts but the low to moderate income people who literally live paycheck to paycheck are facing financial hardships as we speak.

I think the items presented are great undertakings. Small businesses have suffered, so any assistance that can be provided to them is critical. I love the idea of including mortgage assistance along with rental assistance. I know many people do not often think about homeowners' challenges, but they need support as well. The component to address mental health is a dire need for this community. If you address mental health, you indirectly will impact homelessness and drug addiction because both of these populations often struggle with mental health challenges. I am in support of funding being allocated for rental/mortgage assistance and mental health counseling. However, I am opposed to the funding allocation for small businesses. These funds would be better used in another area. The City of Lake Charles submitted a Public Notice announcing a fund allocation for small businesses back in spring/summer 2020. How many businesses have qualified for these funds? How many of these grants have been allocated thus far? The small business program is a duplication of services that are already offered by the federal government. The federal government has re-implemented the Paycheck Protection Plan for small business. The maximum amount of funding that has been proposed for businesses will not keep these businesses afloat. In fact, after most businesses realize the requirements for them to stay in compliance after receiving such small amounts of funds they will probably realize that they have made a mistake.

Another concern that I would like to address. I have reviewed many Public Notices for the City of Lake Charles. These past notices have all advised the public of which organizations were to be funded. This public notice does not provide any information on which organizations will receive the funding. This is supposed to be public knowledge.






