

CITY OF LAKE CHARLES COMMUNITY DEVELOPMENT BLOCK GRANT - DISASTER RECOVERY PUBLIC NOTICE

The City of Lake Charles (COLC) has been allocated an additional \$7,042,000 to the original \$10,776,000 for a total of \$17,818,000 in Community Development Block Grant — Disaster Recovery (CDBG-DR) funding from the United States Department of Housing and Urban Development (HUD) in response to the May 2021 flood event, COLC has updated its CDBG-DR Action Plan to reflect the increased allocation. The Action Plan provides a framework for activities and expenditures for various disaster recovery and community development activities.

On Thursday, March 16, 2023, at 2 p.m. the COLC will hold a public meeting in the Council Chambers at Lake Charles City Hall, 326 Pujo Street Lake Charles, LA 70602. The purpose of this meeting is to gather additional public input and encourage public participation in the planning process for the CDBG-DR allocation.
