The monthly financial reports for June, 2025 were provided to the City Council members by the Department of Finance. The reports include the Budget to Actual Revenues and the Budget to Actual Expenditures.

Mr. Greg Pete, Lake Charles Housing Authority, gave an update on the St. Mary Drive and Greinwich Boulevard projects. He also stated Phase I of Choice Neighborhood partnership with the City and the Parish. should be completed by year end. Phase II will be the senior living cottages. Willow Manor and Woodway Park are in the restoration process.

Mr. Harvey stated that he wanted to clarify that he was disappointed with the actions of the previous Housing Authority administration. During his second year on the council, a public meeting was held in which he and his community were misled about the proposed location of the St. Mary Drive project, which was planned for Moeling Street.

Contrary to some claims, there was never a \$40 million-plus award that was lost due to his actions regarding the potential project. Additionally, no allocation was ever made for a project titled the "Mary Morris Project."
