He also requested the status of the funding and site selection for the indoor sports facility. John Cardone stated that drainage improvement areas are determined with input from each city council member. Mayor Simien stated the indoor sports facility is funded and pending authorization from HUD. The City is still evaluating potential sites and Ward 3 would be contributing \$5M to the project. Councilman Young commended Mr. Bellard for his thorough review. He also thanked Mayor Simien, Emily McDaniel and John Cardone for a well prepared budget and for their efforts in assisting new council members and getting their input as well. He expressed disappointment in the 2% pay raise for city employees and requested the City consider a mid-year raise if feasible. Mr. Young then proposed an amendment to the budget to add one full-time inspector position in the Property Standards Division in addition to the previously proposed full-time positions being added, one in the City Marshal's Office and one in the Recreation Department specifically for lakefront maintenance. Mr. Marks added a stipulation to Mr. Young's amendment that the new inspector position would only be added after all existing open positions are filled. Mr. Harvey seconded the motion and reiterated his request for a task force specifically for District A. The council voted on the proposed amendment as follows.*
