PUBLIC HEARINGS

Jeremy Williams, 124 W. Claude Street, is requesting to build the shop to give a place for he and his three boys to work on cars and also for a boat. His plans are to have the color and trim the same color as his home. Robin Basone submitted a card but only wished to speak if there were any questions for her.
