- 1. Provide a \$7,500 Contractors Bond on City of Lake Charles Bond form. (not required when a homeowner self-contracts his/her primary residence) Form is located on the city website at www.cityoflakecharles.com and can be found by following these steps:

 - 3. Click Forms/Applications
 - 4. Select Bond Form
- 2. Provide a Certificate of General Liability Insurance \$100,000 min. coverage

City of Lake Charles MUST be listed as certificate holder

- 5. Louisiana Contractors License is required for the following:

Commercial projects valued at \$50,000 or more.

Residential projects valued at \$75,000 or more.

Home Improvement projects values between \$7,500 to \$74,999

Plumbing, electrical, and mechanical projects valued at \$10,000 or more.

- 6. Register with Lake Charles Permit Center (7th Floor of City Hall)
- 7. Submit a completed application for Plan Review

8. Pay plan review fees. (Allow 1-3 days for residential, 7-21 days for commercial)

Notes: 1. All Electrical, Plumbing, and Mechanical work performed require additional permits. Plan review for State Fire Marshal is required for all commercial projects.

2. Inspections require 24-hour notice. Inspection request or permit applications received after 3:30 p.m. will not be processed until the following business day.
